Call to Order:

The Public Meeting to adopt the Financial Plan (2018-2019) and proposed Budget for January 1, 2019-March 31, 2020 was called to order at 8:00 p.m.by Mayor, Brendon McKenna. A round table of introductions followed.

Approval of Draft Financial Plan Minutes:

M-1 Motion:

It was moved by Cody Good and seconded by David to approve the March 11, 2019 Meeting minutes. Motion carried.

Review & Adoption of Financial Statements/Proposed Budget:

The Financial Statements and proposed Budget were reviewed. It is noted there will be an increase in tax revenue and \$5,000 was added to the forecast revenue. It was agreed to set aside \$5,000 for Bylaw Enforcement. North River Fire Department was contacted and their rate will remain the same as last year at 7.5 cents for \$100 of assessment.

M-2 Motion:

It was moved by Don Jardine and seconded by Cody Good to adopt the 2018-2019 Financial Statements and amended Proposed Budget for March 31, 2019-March 31, 2020. Motion Carried.

Projected Tax Rate:

The projected tax rate for the Rural Municipality of Brackley is currently .19 cents per \$100.00 of assessment for non-commercial and .95 tax rate per \$100.00 of assessment rate for commercial. For the former community of Winsloe South, the projected tax rate for non-commercial and commercial was 0.085 per \$100.00 of assessment and it will now reflect the same as Brackley. Tax Rate Certificate must be forwarded to Taxation before April 1st.

M-3 Motion:

It was moved by Don Jardine and seconded by Cody Good to approve the current tax rate as presented up to March 31st, 2020. Motion Carried.

Other Business:

Formal approval of using BDO Canada as Auditors was discussed and it was agreed to hire them for the April 1, 2019-March 31, 2020 fiscal year.

M-4 Motion:

It was moved by Amir Zuccolo and seconded by Cody Good hire BDO Canada LLP as Auditors for the 2019-2020 year. Motion Carried.
